

ORDINANCE NO. 2011-39

**AN ORDINANCE APPROVING AN AMENDMENT TO THE
COMPREHENSIVE PLAN FOR THE VILLAGE OF PALOS PARK,
COOK COUNTY, ILLINOIS, AND AMENDING PART TWELVE, TITLE TWO,
CHAPTER 1222 OF THE PALOS PARK VILLAGE CODE IN RELATION THERETO
(BIKEWAY PLAN)**

BE IT ORDAINED by the Village Council of the Village of Palos Park, Cook County, Illinois, as follows:

SECTION 1:

- A. That on May 19, 2011 and July 20, 2011, the Plan Commission held a public hearing in regard to the proposed Bikeway Plan amendment to the Comprehensive Plan for the Village, with said public hearing on May 19, 2011 and July 20, 2011 being held pursuant to the publication of proper notice in compliance with 65 ILCS 5/11-12-7.
- B. That on July 20, 2011, the Plan Commission recommended the adoption of the proposed Bikeway Plan amendment to the Comprehensive Plan for the Village to the Village Council.
- C. That on August 8, 2011, the Village Council held a public meeting relative to the proposed Bikeway Plan amendment to the Comprehensive Plan for the Village.
- D. That on September 26, 2011, the Village Council held a public hearing in regard to the proposed Bikeway Plan amendment to the Comprehensive Plan for the Village, said public hearing being held pursuant to the publication of proper notice in compliance with 65 ILCS 5/11-12-7; a copy of the publisher's certificate relative to said notice is attached heretofore as Exhibit A, and made part hereof.
- E. The Village Council approves and adopts the findings and recommendations of the Plan Commission and incorporates such findings and recommendations herein by reference as if they were fully set forth herein.

SECTION 2: That the Bikeway Plan for the Village, attached hereto as Exhibit B, and made part hereof, is hereby approved as an amendment to the Comprehensive Plan for the Village of Palos Park, Cook County, Illinois.

SECTION 3: That Part Twelve, Title Two, Chapter 1222, Section 1222.02 of the Palos Park Village Code is amended by adding a new subsection (b) thereto, which shall read in its entirety as follows:

“(b) The Bikeway Plan amendment dated September 12, 2011. (Ordinance No. 2011-39). “

SECTION 4: That the Village Clerk is directed to record, with the Recorder of Deeds of Cook County, Illinois, the Notice attached hereto as Exhibit C, and made part hereof, so as to comply with 65 ILCS 5/11-12-7.

SECTION 5: That this Ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form as provided by law.
