IMPORTANT NOTICE TO CONTRACTORS

ORDINANCE 1460.02 has been approved by the Village Council in regard to CONSTRUCTION SITE ENVIRONMENTAL PROTECTION STANDARDS FOR NEWLY DEVELOPED LOTS, TEAR DOWN DEVELOPMENTS, ADDITIONS, AND REMODELING PROJECTS.

CONTRACTORS – In addition to the licensing requirements provided for Chapter 804 of the Village Code, any contractor, subcontractor, or owner in charge of work on such construction site regulated by this Section must, before commencing any work on such construction site, become familiar with the construction site environmental protection requirements of this Section, and sign an acknowledge stating that said contractor, subcontractor, or owner in charge is familiar with all the requirements of this Section, and will comply with all requirements.

A contractor's license WILL NOT be issued until the contractor has read, reviewed and is familiar with the Ordinance.
