Full Year Registration Fee: \$100.00 will be in **effect through December 31, 2022.**

*Note: After September 1, 2022 - December 31, 2022 a partial fee of \$55.00 will be in effect.*

Certificate of Liability Insurance, General Comprehensive Liability - \$300,000 per occurrence with the Village as "Certificate Holder".

Signed Construction Conduct Acknowledgment Form (*attached or reverse*)

Electricians: Provide a current copy of your Certification from an Approved Testing Municipality.

Asbestos, Roofing, Elevator, and Fire Sprinkler Contractors: Provide a current copy of your State License.

Plumbers, Irrigation, Water Well and Private Alarm Contractors: provide a current copy of your State License and are exempt from registration fee.

**Contractors must keep all application information, licenses and insurance up to date – failure to do so shall void the registration.** *Per Village Code 804.17: Registration fees shall be doubled in the event the contractor is required to apply for a registration as a result of having been caught working in the Village without valid registration. Contractors working in the Village with no registration, or a voided or expired registration, shall subject the contractor to stop work orders and fines, as well as any other Code Enforcement options available to the Village.*

*Home Occupation Acknowledgment Form* is required if your office, workshop, or storage facility is located within a residentially zoned area of Palos Park. This form is available online or at Village Hall front desk.

**CONSTRUCTION CONDUCT ACKNOWLEDGEMENT FORM**

We all have a role in protecting, maintaining, and improving our environment. *Construction Conduct* means being a good neighbor. Village Code Chapters 1460, 652, and 480 defines appropriate conduct on construction sites. Please review codes on-line or get a copy at the Kaptur Center. The goal is to keep undesirable impacts to a minimum. Respect for neighbors, safety, and cleanliness will lead to a successful construction project.

**Requirements:**

1. **Contractors** work hours are Monday through Friday 7AM – 8PM or dusk if earlier and Saturday 7AM – 5PM or dusk if earlier and not on New Year’s Day, Memorial Day, Independence Day, Labor Day, Thanksgiving, and Christmas. **Homeowners** may do construction Monday – Saturday 7AM – 9PM or dusk if earlier and Sundays and Holidays 10AM – 6PM or dusk if earlier.
  
2. Conduct standards include:
 

<p><b>Keep site and equipment safe</b>  <b>Do not store dirt, materials, or containers on parkway</b>  <b>No trespass on neighbors’ land or driveways</b>  <b>Put waste in containers and haul away when full</b>  <b>Do not compromise protection fences</b>  <b>Do not park off-site unless pre-approved in writing by the Village</b>  <b>Restrain silt, gravel, trash, refuse and other items from being washed, blown, carried or otherwise conveyed off of the site.</b></p>	<p><b>Clean mud off streets</b>  <b>No burning</b>  <b>Do not obstruct traffic</b>  <b>Keep noise to a minimum</b></p>

3. For larger jobs, such as new buildings and additions, a Conduct Plan is required to be submitted with a permit application: identify the disturbance area on the site plan along with locations for access, excavation spoils, material stockpiles, dumpster, toilet, 6’ high chain link protection fence, concrete truck washout area, parking, and notice letters to the neighbors. Samples of a plan and letter are in the Code. The Village will post a sign on these large construction sites summarizing the Conduct Standards.
