

## **INTERGOVERNMENTAL AGREEMENT TO PROVIDE FOR NONRESIDENTS USE OF SWIMMING POOL FACILITIES**

THIS AGREEMENT is entered into this 9<sup>th</sup> day of April, 2013 by and between the City of Palos Heights, an Illinois Municipal corporation (hereafter referred to as "City") and the Village of Palos Park, an Illinois Municipal corporation (hereafter referred to as "Municipal Partner") under authority of Section Ten (10) of Article VII of the Illinois State Constitution and the Intergovernmental Cooperation Act (5ILCS 220/1 et seq.)

WHEREAS, the City owns and operates a swimming pool and related facilities located at 7650 W. College Drive;

WHEREAS, the City sells both annual fee membership and daily use passes to the public to allow the use of the facilities;

WHEREAS, the City Council of the City wishes to extend membership to residents of neighboring governmental units; and

WHEREAS, neighboring governmental units have expressed an interest in allowing and providing their residents an opportunity to utilize the City's facilities;

NOW, THEREFORE, it is hereby agreed as follows:

1. The City shall allow residents of the Village of Palos Park to purchase annual memberships to utilize the swimming pool facilities located at 7650 W. College Drive under its Municipal Benefit Program. Said membership shall be purchased from each Municipal Partner.
2. The Municipal Benefit Program of the City is set forth herein:

### **Benefits of Partnership/Membership Privileges**

- Offers your residents an opportunity to obtain membership at a reduced rate.
- Reduced rate for swim lesson programming.
- Outdoor swimming in 50 meter pool.
- Complementary passes.
- Special Event Programming: Wacky Wednesdays

### **Municipal Partnership Fee**

## **Family**

- \$205.00 preseason price on family pass of four if purchased by Friday, May 31.
- \$235.00 season price on family pass of four if purchased June 1 and after.

## **Individual**

- \$90.00 preseason price on individual pass if purchased by Friday, May 31.
- \$105.00 season price on individual pass if purchased June 1 and after.

## **Senior**

- \$65.00 preseason price on senior pass if purchased by Friday, May 31.
- \$90.00 season price on senior pass if purchased June 1 and after.

## **Pass Membership Perks**

- Municipal Partnership Families receive 3 complementary passes.
- Municipal Partnership Individuals or Seniors receive 1 complementary pass.
- Swim Lessons are \$35 for members.

## **Hours of Operation**

- Regular Pool Season runs Saturday, June 1-Sunday, August 18. The Pool will also be open on weekends through Labor Day, Sat-Sun, Aug 24-25 from 12-5 and Sat-Mon, Aug 30-Sept 1 from 12-5.
- Monday-Friday, Early Bird/Lane Rentals 5:45-8:45 a.m.
- Monday-Thursday & Saturday, Swim Lessons/Water Exercise 9:00-11:35 a.m.
- Sunday-Saturday, Open Swim Noon-7:00 p.m..
- Holiday Hours, Noon-5pm (July 3rd & 4<sup>th</sup> and weekends through Labor Day starting August 24).

3. Upon proper proof of personal identification and residency in the Village of Palos Park the City shall sell an annual membership for the use of its facilities to the applicant.

4. Purchaser shall be responsible for obeying and following all rules and regulations established by the City for the use of its facilities.


5. The Village of Palos Park shall advertise and promote the opportunity to its residents to participate in the Municipal Benefits Program of the City.

6. **Counterpart Execution.** This Agreement may be executed in duplicate originals or in any number of counterparts with the same effect as if all parties hereto have executed the same document. All counterparts shall be construed together and shall

constitute one agreement. This Agreement does not take effect until executed by all parties.
